In not issuing any further action, Stewards were mindful of the greyhound's relative race inexperience (2nd race start), the minor nature of the incident and the distance of the lure from the greyhound.		
6 Zipper Zone	Underwent a post-race veterinary examination at the request of trainer Shane Cartwright which revealed a near fore toe laceration. 14-day incapacitation period issued.
